SECTION 1. LEGISLATIVE INTENT

It is the intent of the Town Board of the Town of Sangerfield to provide a real property tax exemption to qualifying volunteer firefighters and volunteer ambulance workers as set forth in Real Property Tax Law §466-a.

SECTION 2. AUTHORITY

Real Property Tax Law §466-a authorizes the Town Board to adopt a local law providing a real property tax exemption of up to 10% of the assessed value of real property owned by the qualifying volunteer firefighters and volunteer ambulance workers.

SECTION 3. GRANT OF EXEMPTION

An exemption of 10% of assessed value of property owned by an enrolled member as set forth below, or such enrolled member and their spouse, is hereby granted from taxation with respect to the real property taxes of the Town of Sangerfield as long as eligibility requirements provided by this chapter are met.

SECTION 4. ELIGIBILITY REQUIREMENTS.

Such exemption shall be granted to an enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service provided that:

- A. The property is owned by the volunteer firefighter or volunteer ambulance worker;
- B. The property is the primary residence of the volunteer firefighter or volunteer ambulance worker;
- C. The property is used exclusively for residential purposes;
- D. The volunteer firefighter or volunteer ambulance worker resides in the Town of Sangerfield and the Town of Sangerfield is served by such incorporated volunteer fire company or fire department or incorporated voluntary ambulance service;
- E. The volunteer firefighter or volunteer ambulance worker is certified by the authority having jurisdiction as an enrolled member of such an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service; and
- F. The volunteer firefighter or volunteer ambulance worker meets the minimum service requirement established by the Town of Sangerfield, which is hereby established as three (3) years.

SECTION 5. APPLICATION

A volunteer firefighter or volunteer ambulance worker must annually, on or before the applicable taxable status date, file an application for such property tax exemption with the assessor responsible for preparing the assessment roll for the Town of Sangerfield, on a form as prescribed by the New York State Commissioner of Taxation and Finance. The Town of Sangerfield must maintain written guidelines, available upon request, as to the requirements of an enrolled volunteer member relating to this exemption.

SECTION 6. CERTIFICATION

The Town of Sangerfield Town Board must annually file with the Town Assessor, prior to the applicable taxable status date, a list of the active volunteer members who are certified to meet the minimum service

requirement. Such list must provide, as of the applicable taxable status date, the number of years of service served by each such enrolled volunteer member and such enrolled volunteer member's address of residence.

SECTION 7. NO DIMINUTION OF BENEFITS

An applicant who is receiving any benefit pursuant to Article 4 of the Real Property Tax Law as of the effective date of this Law shall not have any of those benefits diminished because of this Law.

SECTION 8. GRANT OF LIFETIME EXEMPTION

Any eligible enrolled volunteer member who accrues more than 20 years of active volunteer service (as certified by the authority having jurisdiction) shall be granted the 10% exemption as authorized by this Law for the remainder of his or her life as long as his or her primary residence is located within the Town of Sangerfield.

SECTION 9. UN-REMARRIED SPOUSE OF ENROLLED VOLUNTEER MEMBER KILLED IN THE LINE OF DUTY

The un-remarried surviving spouse of a deceased enrolled volunteer member killed in the line of duty, as certified by the authority having jurisdiction, is qualified to continue to receive an exemption, as long as the deceased volunteer member had been an enrolled volunteer member for at least five years and had been receiving the exemption at the time of his or her death.

SECTION 10. UN-REMARRIED SPOUSE OF DECEASED ENROLLED VOLUNTEER MEMBER

The un-remarried surviving spouse of a deceased enrolled volunteer member, as certified by the authority having jurisdiction, is qualified to continue to receive an exemption as long as the deceased volunteer member had been an enrolled volunteer member for at least 20 years and had been receiving the exemption at the time of his or her death.

SECTION 11. VALIDITY AND SEVERABILITY

If any clause, sentence, paragraph, section, or part of this Local Law is declared by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to said clause, sentence, paragraph, section or part of this Local Law.

SECTION 12. EFFECTIVE DATE

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Municipal Home Rule Law Section 27.
