PRIOR WRITTEN NOTICE LOCAL LAW 1-2022  
(A Local Law Imposing Prior Written Notice of Highway Defects)**

**NOTICE OF HIGHWAY DEFECTS**

**Local Law # 1-2022 of the Year 2022**

**A local law providing for written notification of defects and obstructions on town highways, bridges, streets, sidewalks, crosswalks, and culverts in the Town of Sangerfield.**

**Be it enacted by the Town Board of the Town of Sangerfield.**

**Section 1. No civil actions shall be maintained against the town or town superintendent of highways for damages or injuries to person or property sustained by reason of any highway, bridge, street, sidewalk, crosswalk, or culvert being defective, out of repair, unsafe, dangerous, or obstructed unless written notice of such defective, unsafe, dangerous, or obstructed condition of such highway, bridge, street, sidewalk, crosswalk, or culvert was actually given to the town clerk or town superintendent of highways, and there was a failure or neglect within a reasonable time after the filing of such notice to repair or remove the defect, danger, or obstruction complained of.**

**Section 2. The town superintendent of highways shall transmit in writing to the town clerk within five days after the receipt thereof all written notices received pursuant to this local law and subdivision 2 of section 65-a of the Town Law. The town clerk shall cause all written notices received pursuant to this local law and subdivision 2 of section 65-a of the Town Law, to be presented to the town board within 5 days of the receipt thereof or at the next succeeding town board meeting, whichever shall be sooner.**

**Section 3. This local law shall supersede in its application to the Town of Sangerfield subdivisions 1 and 3 of section 65-a of the Town Law.**

**Section 4. This local law shall take effect immediately upon its filing in the office of the Department of State.**

**Please note that Town Law Section 65-a, Subdivision 4, requires the Town Clerk to keep a separate indexed record (by Location) of all such notices received. In the event of litigation, the Town will be expected to demonstrate compliance with this provision.**


